## Lifting of Color Zone Restrictions

Effective Monday, April 30 through Sunday, August 19, all zones except UV Garages, Purple, Gables One Tower, and Reserved lots, will continue to be enforced throughout the summer. A valid UM Parking Permit is still required to park on campus during enforcement hours, which are as follows:

- All Color Zones (except Purple): Monday Friday, 8:00AM to 4:00PM
- Purple: Monday Friday, 8:00AM to 6:00PM
- Reserved: 24/7/365 (at all times)

Vehicle information may be entered in the system at any time. You will need your vehicle make, model, year, color and license plate number. Participants in the University of Miami Public Transit Program and first year resident students are ineligible to apply for a parking permit. # **Extended Enforcement**

Effective Monday, August 20, 2018, parking enforcement hours at the Coral Gables Campus and Gables One Tower will be enforced 7-days a week from 8:00AM to 11:00PM. All vehicles will be required to have their license plate registered with the university during enforcement hours.

Gables Campus and Gables One Tower: Parking Enforcement Hours Extended To 7-days a week from 8 a.m. to 11 p.m.

Nights and Weekend Parkers: Changes apply; please review the following parking options: <u>Faculty, Staff, Students:</u>

- Nights and Weekend Parking Permit: This is a new permit that will be introduced during the Permit Season Sale in July 2018. The permit is valid 4 p.m. to 11 p.m. Monday – Friday, and 8 a.m. to 11 p.m. on weekends in all parking zones. The cost of the permit (\$260 annually) will be waived for UM Faculty, staff, students and third party employees during the 2018-19 academic year to help with the transition into this new policy.
- PayByPhone: The widely utilized payment application will be available throughout the lots and garages (except: Preferred, Reserved, and Service spaces) 4 p.m. to 11 p.m. Monday – Friday, and 8 a.m. to 11 p.m. on weekends.
- On-foot Pay Stations: Additional Pay Stations will be strategically placed throughout the Gables Campus; for locations, see the <u>Map</u>.

# 2018 FALL MOVE-IN

Students who reserved a container storage unit (i.e. POD) will be able to schedule the delivery to campus as early as August 3, 2018. # **No Back-In Policy**

Effective Monday, February 19, 2018, all vehicles parked on the Coral Gables campus and Gables One Tower must have their license plate number facing outward in order for it to be read by the License Plate Recognition (LPR) enforcement cameras.

Drivers with out-of-state vehicles that have both a front and back plate will be able to back-in. Drivers not having a front plate may purchase a "vanity" front plate from the Parking and Transportation Office located at the McKnight Building Suite 100. Be sure to familiarize yourself with the No Back-in regulations.
